

TCVMA LIABILITY WAIVER

(Signature is required to be eligible to attend any TCVMA meeting)

I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the Center of Disease-Control (CDC) and many other public health authorities still recommend practicing social distancing. To this extent, the TCVMA and The Pelican Yacht Club will be adhering to the CDC guidelines with regards to social distancing practices and sanitation. Prior to and during the meeting we will ask that our attendees attest to their health history and continue to implement these sanitation and disinfection procedures.

I further acknowledge that the TCVMA cannot guarantee that I will not become infected with the Coronavirus/Covid-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, staff and their families.

I voluntarily request the opportunity to be eligible to attend the in-person TCVMA meetings and acknowledge that I am increasing my risk of exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while attending the meeting.

I attest that:

- * I am not experiencing any symptom(s) of illness such as cough, shortness of breath, difficulty breathing, fever, chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- * I have not traveled internationally within the last 14 days and I do not plan on traveling internationally prior to the TCVMA meetings.
- * I have not traveled to a highly impacted area within the United States of America in the last 14 days.
- * I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- * I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- * I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold the Pelican Yacht Club, the TCVMA, the Sponsor(s), the Animal Emergency and Referral Center and the Employees, Management, Board Members, Doctors and Staff of all these entities, harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses, and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, or that may otherwise arise in any way in connection with attending the TCVMA meetings.

I understand that this release discharges the Pelican Yacht Club, the TCVMA, the Sponsor(s), the Animal Emergency and Referral Center and the Employees, Management, Board Members, Doctors and Staff of all these entities from any liability or claim that I, my heirs, or any personal representatives may have against these entities with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to with attending the TCVMA meetings.
